Due to the limited number of available bowling lanes, the Presidio Bowling Center requires a **\$100.00 NON-REFUNDABLE** reservation deposit for 1-4 lanes and a **\$200.00 NON-REFUNDABLE** reservation deposit for 5-8 lanes, which will be credited to your event's account. This payment must be made in the form of **Cash, Check, Mastercard, Visa, American Express or Discover**. An ATM is on site for your convenience. Should a change or cancellation be necessary, a minimum of TWO WEEKS advance notification will be required. Your deposit will be credited to a future event or you will receive house credit. No changes in date or time will be permitted within two weeks of event date.
